### LICENSE RENEWALS

90% of individuals have completed their license renewals. **Thank you!** For those licensees and principal brokers who have yet to renew their individual and/or firm licenses, please be reminded that any licenses (individual or firms) that have not submitted

both the renewal and payment prior to **September 30, 2022** will lapse automatically effective **October 1, 2022**. This means the individual or firm will not be licensed to sell insurance. You will be required to complete a late renewal application that is subject to an additional fee. A full reinstatement, including payment of penalty fees will be required for any applications received after **October 15, 2022**.



### UPGRADING TO A LEVEL 2 LICENSE!

**Effective August 10, 2022**, individuals are no longer required to submit a Principal Broker support letter as part of their Level 2 Technical exam waiver request. Click the link [here](#) to find out more.
