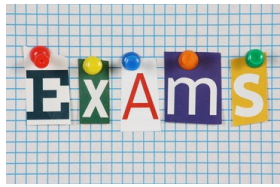
EMPLOYMENT CHANGES WEBPAGE NOW LIVE!
