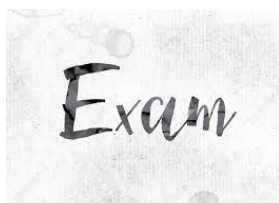

SUBMIT YOUR CURRENT E&O/FIDELITY INSURANCE CERTIFICATES

You can now submit your current E&O/Fidelity insurance certificates directly to RIBO for processing through the [member portal](#). In the portal, select your Firm and navigate to the 'Request' tab. Click on the option to enter & upload copies of your insurance certificates.

Please note: you can only submit **one** coverage entry request at a time, for multiple requests, wait for the first one to close, then submit the next. Open & Closed statuses can be tracked from the 'Request' tab. **Only the certificate is required, please do not upload the entire policy.**
