An overwhelming number of respondents provided feedback on our broker competency profile survey – **Thank You!** The vast majority responses said RIBO should require a mandatory training course as a

prerequisite for licensing. There was a 50-50 split in the responses to questions about whether brokers should hold a separate license to sell commercial products, or whether brokers should be able to sell travel products with their RIBO license. # QUEBEC SEASONAL HOMES AND LICENSING REQUIREMENTS

The RIBO license authorises brokers to solicit or procure insurance contracts for persons or property within the province of Ontario. This includes providing insurance advice to Ontarians. If you have clients with seasonal homes in Quebec, you are required to hold a license in Quebec. Jurisdictions may vary on their licensing requirements when writing business for a client's secondary home or business location. You should always check with the local regulator of that jurisdiction to determine what type of licensing may be required. A list of regulators may be found <u>here</u>.

**REMINDER!** When individuals are applying for their new license, please ensure that their employment confirmation forms are completed, signed and dated before sending to the individual. Stale dated and incomplete forms result in licensing delays.



## IT'S YOUR OBLIGATION TO DISCLOSE

This is a reminder to brokers, who participate in any new business or renewal incentives offered by insurance companies, including contest entries and/or 'bonus' commissions, of your obligation to disclose to the consumer any commissions, bonuses, prizes you receive as part of your broker compensation. Full transparency and disclosure must be given to consumers to ensure that they are making a fully informed decision before purchasing the policy. Such disclosure should be included in your firm's easy to locate broker Conflict of Interest document.
