#### **License Renewals**

## You must renew your license on or before September 30, 2023 to avoid being deregistered!

As a reminder your renewal consists of both completing and submitting the renewal questionnaire and providing payment of the renewal fee.

Should you fail to renew by **September 30th**, a full reinstatement will be required (including penalty payment). We remind everyone that it is an offence for a deregistered broker to speak to the public on any insurance matter until a reinstatement has been fully processed and confirmed by RIBO.
