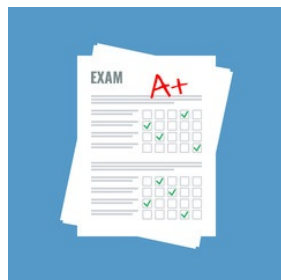
Get your Continuing Education credits!
