Fulfilling this obligation includes sufficiently understanding your client's risk exposure, and informing them of the facts and assumptions upon which your recommendations are based. Services by Certain Insurance Intermediaries

The Canada Revenue Agency has released a Notice for comment regarding the application of GST/HST to supplies made to an insurer, or to another person or company that has an agreement with an insurer including any delegated underwriting agreements. You may wish to <u>review the Notice</u> to determine if it applies to your organization. The deadline to comment on this GST/HST Notice is **October 31**, **2023**.


